Additionally, in accordance with Section 1557 of the Patient Protection and Affordable Care Act of 2010, 42 USC § 18116, the hospital does not exclude, deny benefits to, or otherwise discriminate against any person on the ground of sex (including gender identity) in admission to, participation in, or receipt of the services and benefits under any of its health programs and activities, and in staff and employee assignments, whether carried out by the hospital directly or through a contractor or any other entity with which the hospital arranges to carry out its programs and activities.
